REPORT OF THE TRUSTEES FOR THE YEAR ENDED 30 JUNE 2015

The Trustees present their report along with the financial statements of the charity for the year ending 30 June 2015.

Structure, Governance and Management

The Heritage Crafts Association is a Charitable Incorporated Association (CIO) registered with the Charity Commission in November 2014. The decision to transfer the previous registered charity (established in January 2010) from its status as an unincorporated association to a CIO was taken at the Annual General Meeting in March 2014. During the following months the Trustees worked to action this change and all the steps were completed in May 2015. The charitable aims, activities and objectives remain identical under the CIO structure.

Membership is open to individuals over the age of eighteen, and organisations approved by the Trustees. A Trustee must be a member of the charity or a nominated representative of an organisation that is a member of the charity. Trustees are appointed by the members at the Annual General Meeting and serve for three year terms, although they are eligible for re–election.

Objects and Activities

The Heritage Crafts Association is the advocacy body for traditional heritage crafts. Working in partnership with Government and key agencies it provides a focus for craftspeople, groups, societies and guilds, as well as individuals who care about the loss of traditional crafts skills, and works towards a healthy and sustainable framework for the future.

The charitable remit of the Heritage Crafts Association is to advance public knowledge and appreciation of traditional crafts, in particular, but not exclusively, through education, advice and training.

This is done by:

- Surveying researching the status of heritage crafts, identifying those crafts in decline or in imminent danger of being lost, and addressing the issues to ensure their survival.
- Advocating communicating the vital importance of the heritage crafts to Government, key agencies and organisations.
- Celebrating raising awareness and raising the status of heritage craft skills with the wider public through a programme of public relations, communications and showcase events.
- Safeguarding working in partnership with key agencies in the education and learning sectors to identify and support new and innovative ways to ensure that the highest standard of heritage skills are passed from one generation to the next and where necessary recorded for posterity.
- Supporting to support heritage crafts through a range of means, including advice, networking, training and access to public and private funding.

Achievements and Performance 2014-15

Heritage Crafts Awards

The Heritage Crafts Awards continued for the third year running. The Marsh Christian Trust kindly funded and supported awards for Heritage Crafts Volunteer, Heritage Crafts Trainer, and Heritage Crafts Made in Britain. The award for Maker of the Year was funded anonymously. NADFAS awarded £6,000 for a calligrapher or letterer as part of the David Bell Memorial Fund. This year the HCA was asked by QEST to administer a number of awards in addition to the Heritage Crafts Trainee, including for stone, embroidery and culinary skills.

Ladder Making Project

The HCA, with the support of the Foyle Foundation, has run a project to preserve the skill of wooden ladder making utilising the knowledge of Stanley Clark, and to disseminate these skills.

The HCA was able to run two workshops with Stanley to pass on his knowledge. The first was a small workshop in Northampton where Stanley taught Robin Wood (green woodworker and HCA Chair) and Steve Tomlin (woodworker and QEST craft scholar) how to make a ladder. This workshop was filmed to produce an online resource. During the project, two different styles of ladder were made (a builder's ladder and a thatcher's ladder) to demonstrate the considerations given to the design of a wooden ladder. The second workshop had ten participants, so that Robin and Steve could share their learning with a wider group of craftspeople. This workshop was made available free of charge to interested HCA members and was advertised on the HCA website.

Photography Competition and Exhibition

One of the highlights of London Craft Week (6–10 May 2015) was the HCA's Photography Competition, held in association with Furniture Village, to celebrate heritage crafts and raise awareness of and raise the status of heritage craft skills. The exhibition was held at The Prince's Foundation in London, with the opening on 7 May 2015 where the winners were announced. Lucy Saggers from North Yorkshire was announced the overall winner and winner of the 'Craftspeople at Work' category with her entry *Farrier Tom at work in late winter sun*. Linda Laird from Orkney won 'The Essence of Crafts' with her series of photographs of an Orkney chair being made. Gabriel Langley from County Durham was the winner of the 'Under–16' category. The winning photographs and others from the shortlist remained on display at The Prince's Foundation until 15 May. Well done and thank you to all our entrants.

The HCA Spring Conference

This year, the HCA's annual conference was held in May so as to be part of the inaugural London Craft Week, with the theme 'A Place for Craft'. Almost 200 people attended the conference, which highlighted the relationship between crafts and location, focusing on those crafts which have developed in particular regions or locations and why craftspeople have chosen to live and work in areas with a special tie to their craft.

We had wonderful and inspiring speakers including Sir Christopher Frayling, HCA Patron, and Genevieve Sioka, artisan and craft buyer with the National Trust. Sessions with speakers Mark Hogarth (Harris Tweed Hebrides), Felicity Irons (rush weaver and designer), Richard Eaton (potter and designer at Denby Pottery) and Veronica Main (significant collections curator at Luton Culture) whose talk focused on straw plaiting in the hat industry, also serve to remind us of the diverse range of skills included within heritage crafts.

We were also delighted to recognise our Heritage Crafts Awards winners and recipients of bursaries during the conference. Owen Morse Brown, a hat block maker from Wiltshire was selected as Maker of the Year. The award for Made in Britain went to Charlie Trevor, the man behind Equus Leather. Ceramicist Mary English from Surrey won the award for Best Trainer, and the award for Volunteering went to Glaswegian lacemaker Jean Leader. The NADFAS bursary was awarded to Edinburgh-based letter-carver Luke Batchelor, and shoemaker Bethan Horn from Cardiff won the QEST Training Bursary.

The HCA Annual General Meeting was held at the conference. The Annual Report and Accounts for 2013–14 were presented. The membership voted to complete the final steps to transfer the membership of HCA to the newly established Charitable Incorporated Organisation (CIO) and to close the old unincorporated charity, and elected the Trustees and Officers of the new CIO. National Honours for Craftspeople

The HCA has continued with its 100% success rate in nominating heritage craftspeople for National Honours. Lida Kindersley, letter cutter, and Hector Cole, arrowsmith and historical metal worker, received MBEs in the New Year's Honours (2015), and Ray Key, wood turner received a BEM in The Queen's Birthday Honours (2015).

We are delighted that at last craftspeople who are world-renowned and put back so much to their craft and community are gaining the recognition they deserve. Ray Key's words sum this up "I hope craftspeople get more recognition ... a lot of people put in the time, not for personal gain, but for the betterment of their craft".

The HCA Website

During the year work began on the improvement of the HCA Directory (The Makers) on the website, using the grant received from the HLF. Work on this has taken longer than hoped and continues into 2015–16. We hope that members will bear with this delay and look forward to launching The Makers website once development is complete. We will continue to update members on this useful tool through our newsletter.

In the second half of our financial year (1 January to 30 June 2015) we had over two million hits to the website (2,273,004) from 61,651 unique visitors over 107,368 visits.

The HCA's Advocacy and Representation Work

The Winston Churchill Memorial Trust have announced the recipients of the new fellowships awarded in conjunction with the HCA. Congratulations to Ruth Davey (shoemaker), David Armes (letterpress printmaker), Charles Collis (violin maker), Patricia Reynolds (former HCA Co-ordinator), Michael Flannery (horologist), Charlotte Howarth (lettering artist), Hugh Miller (furniture maker), Clementine Nuttall (stone conservator and sculptor), and George Cunningham (furniture maker).

- The HCA is represented by Vice-Chair Patricia Lovett as one of the four Strategic Partners for London Craft Week, and played a large part in steering the programme. The HCA Annual Conference was the only full conference to be part of London Craft Week.
- The HCA has been represented on the Craft Industry Board by Vice-Chair Patricia Lovett. The Board meets four times a year and has representation from across the craft sector as well as from DCMS and BIS. Sadly Creative and Cultural Skills decided to close this board In 2015 and will focus on a much narrower remit.
- The HCA is represented by Vice-Chair Patricia Lovett on the All Party Parliamentary Group for Art, Craft and Design in Education. The group works to encourage and highlight the teaching of art, design and craft at all levels of education.
- Funding was not available to support HCA representation on the BIS/CCS Craft Trailblazer although Pat Reynolds, representing the HCA, was praised highly for her contribution.
- The online HCA Newsletter is sent out once a month to friends and VIPs. It contains items to do with HCA activities and achievements, and news from members and societies, together with a craft video of the month.

The HCA Trustee and Staff News

The HCA welcomed new Trustees Dr Chrissie Freeth and Daniel Harris. The HCA thanks Dr Patricia Reynolds for her role as HCA Co-ordinator until February 2015; she continues to be involved in HCA projects and we are very grateful to continue to have her expertise available. The HCA welcomed Chloe Marley as part-time Administrator in February 2015 but sadly Chloe was only able to stay for a short time, and in July 2015 we welcomed Emma Turner as the new part-time Administrator.

Benefactors

We are most grateful to the Headley Trust for continuing to fund the HCA Administrator.

The Foyle Foundation kindly gave a grant for a project to preserve the craft of wooden ladder making which the HCA is match-funding. The main aspect of this project was completed during the year, with workshops held and a DVD and web-based video produced.

The Radcliffe Trust have kindly provided a grant for a strategic project to create 'The Radcliffe Red List of Crafts in Jeopardy in the UK', which will provide essential decision–making information to all those concerned to increase the sustainability of crafts. This includes funders, advocates, and individuals who wish to take action. Work on this project began in March 2015 but the bulk of the work will take place in the 2015–16 financial year.

The HCA is most grateful to the Marsh Christian Trust for continuing to fund the Marsh Heritage Crafts Volunteer, the Marsh Heritage Crafts Trainer and the Made in Britain Award, and to QEST, NADFAS and an anonymous donor for funding other bursaries and awards.

The HCA is also most grateful for all small and large contributions from individuals. It does make such a difference to what we are able to do for heritage crafts. The HCA receives no funding from the UK government and so is wholly reliant on these grants, donations and the membership fees. The Trustees would like to thank everyone for their support.


Financial Review

As discussed above, the Heritage Crafts Association changed its status during this financial year from an unincorporated registered charity to a Charitable Incorporated Organisation (CIO). The change took place during the year and by 30 June 2015 all assets, liabilities, contracts and cash had been transferred to the new CIO. However, as the aims, activities and membership of the two organisations are identical the accounts are presented for the two organisations combined in order to provide meaningful information and comparatives.


The Heritage Crafts Association's net incoming resources for the year were £52,485 (2014: £35,440) and the closing cash reserves held at 30 June 2015 were £49,302 (2014: £39,172). Of the closing cash reserves at 30 June 2015, £21,397 relates to restricted funding received in advance for the next financial year (2014: £20,988).

We thank all donors who continue to support the HCA. The amount of restricted funds received in the year to 30 June 2015 was £28,650, a small increase as an additional grant was received from the Headley Trust to continue to fund the administrator role (2014: £23,400). Unrestricted income has increased to £23,835 (2014: £12,040) due to increased membership income, sponsorship received for the photography exhibition and an increase in unrestricted donations received. The analysis below therefore shows this restricted income separately from the unrestricted funds.

The Headley Trust continues to provide funding for the HCA Administrator. The Radcliffe Trust provided a grant during the year to create a 'Red List of Crafts in Jeopardy in the UK'. This project will take place primarily in the 2015–16 year. An anonymous donor provided support for the Heritage Craft Awards. The Heritage Lottery Fund provided a grant in the previous year to develop the HCA Directory (The Makers).

The main changes compared to the previous year have been an increase in income from membership, an increase in the amount of donations received and an increase in ticket sales, with sponsorship of the 2015 Photography Competition also being included here.

We have continued to manage costs as prudently as possible. The largest item of expenditure remains the cost of our Administrator, which is currently funded from restricted income and so not included above. The cost of running events continues to be a large part of our other costs. The 2015 Spring Conference made a small profit, compared to a small loss on the 2014 Spring Conference.

Trustees are not remunerated for their work with the HCA. Travel costs incurred in attending committee meetings and attending advocacy meetings on behalf of the HCA are reimbursed and, as the Trustees are based throughout the UK, this remains a relatively large element of expenditure at 8% of total costs (2014: 11%).

The growth of the membership remains key to the growth plans for the HCA and to ensure we can demonstrate the wide support for our policies. Membership numbers have remained relatively stable during the current year.

At 30 June 2015 the HCA had 421 members (30 June 2014: 424 members). Of this total 54 members are organisations and businesses and 367 are individuals (30 June 2014: 65 and 359 respectively). The membership fees are £20 for individuals and sole traders, and £40 for businesses, craft guilds and membership organisations (these membership rates were applied following the March 2014 AGM).

Future financial plans

The focus of the Trustees for future financial years is to move towards the HCA being self-funding for core costs, while still working in partnership with other organisations to deliver key projects to promote and develop heritage crafts.

Reserves policy

The Trustees agreed that the equivalent of three month's expenditure should be kept in reserve from unrestricted funds to ensure that the charity could continue to work through any period of unforeseen difficulty. The Trustees assess the reserves policy on an annual basis. The agreed level of reserves was maintained throughout the period.

Risk management policy

Actions have been taken to resolve the principal risks identified by the Trustees in a recent Risk Management Review. These were:

- Failure to generate effective fundraising strategy. To minimise this risk, Trustees will agree a fundraising strategy for one to three years, and review fundraising activities and options at each Trustee meeting. They will appoint one Trustee to provide oversight of fundraising opportunities and activities.
- Failure to generate necessary income. To minimise this risk, Trustees will agree an annual budget identifying planned expenditure and the level of income required. They will ensure that accurate financial records are kept and will monitor income and expenditure to date at each Trustee meeting.

Public benefit statement

The Trustees have kept in mind the Charity Commission's guidance on public benefit at Trustee meetings and when making decisions around the implementation of the objects and activities of the HCA.

Independent examiner's report to the Trustees of the Heritage Crafts Association

I report on the accounts of the Heritage Crafts Association for the year ended 30 June 2015, which are set out on pages 14 to 18.

Notes to the Accounts

1. Accounting policies

a) Basis of accounting

The Heritage Crafts Association (HCA) currently has gross income of less than £250,000 per annum and so prepares receipts and payment accounts as permitted by the Charities Commission.

As explained above the HCA changed its status during this financial year from an unincorporated registered charity to a Charitable Incorporated Organisation (CIO). The change took place during the year and by 30 June 2015 all assets, liabilities, contracts and cash had been transferred to the new CIO. However, as the aims, activities and membership of the two organisations are identical the accounts are presented for the two organisations combined in order to provide meaningful information and comparatives.

b) Incoming resources

All income, donations and subscriptions are accounted for as received by the HCA.

c) Restricted funds

Restricted Funds are funds which are used in accordance with specific instructions imposed by the donor. Details of the Restricted Funds received by the HCA are provided in Note 6 below.

d) Resources expended

Resources expended are recognised in the period in which they are incurred.

2. Administration expenses

The grants from The Headley Trust and the Tedworth Trust were provided to fund the salary of the HCA Administrator for two years to 31 January 2015. Subsequently The Headley Trust have provided a new grant to fund the salary of the HCA Administrator for two years from January 2015 to January 2017.

The grant from the Radcliffe Trust was provided to create a 'Red List of Crafts in Jeopardy in the UK', a strategic project which will provide essential decision-making information to all those concerned to increase the sustainability of crafts, including funders, advocates, and individuals who wish to take action. This project will take place primarily in the 2015-16 year.

The HCA is grateful to an anonymous donor who provided £1,000 for the Maker of the Year Award. Please visit www.awards.heritagecrafts.org.uk for further details of the Heritage Crafts Awards.

The grant from the Heritage Lottery Fund has been received to develop the online HCA Directory online (The Makers) which will enhance the experience of members who are craftspeople. The HCA committed staff time and funds totalling £3,996 to match this funding, of which £876 has been incurred to 30 June 2015.

The grant from the Foyle Foundation has been received towards the ladder making project to preserve the skill of wooden ladder making. The HCA has committed £5,000 of matched funding for this project, of which £487 has been incurred to 30 June 2015.

8. Taxation

As a registered charity the HCA is exempt from corporation tax since all income is applied for charitable purposes.

During the year the HCA submitted Gift Aid claims for the period to 9 May 2015 (the period up until membership was transferred to the CIO) and received £1,526 (2014: £883) from HMRC. The HCA plans to register the CIO for Gift Aid and will then ask members to confirm Gift Aid declarations for the new entity.

9. Asset purchases

During the year the HCA purchased a laptop for the use of the Administrator for £399 (2014: the HCA did not make any asset purchases).
